Members of the public expressed their concerns regarding the following issues from the Stanley Street development:

- Noise on the site generally and that arising outside permitted hours.
- Vibration issues
- Dirt and dust on the road
- Lorry engines idling whilst waiting for the site to open.
- Inaction on enforcement issues from AVBC
- Non compliance of pre development conditions on site and reported health issues.

There were also queries on what AVBC borough councillors were doing about the issues raised.

Cllr McCabe informed residents that officers from AVBC had been informed and were monitoring the situation. He explained the different agencies involved in dealing with the issues. Cllr Sherman read out an extract from correspondence received from the UKHSA dated 10/8/23 stating its position on the health issues referred above. Cllr McCabe informed the meeting that AVBC were commissioning an independent expert to review the scientific findings.
